

## **Scott Huck Photography Wedding Photography Contract**

- It is understood that Scott Huck Photography is the exclusive official photographer retained to perform the photographic service requested on this contract.
- Scott Huck Photography may substitute another photographer to take the photographs in the event of illness or emergency. In the event of such substitution, Scott Huck Photography warrants that the photographer taking the photographs shall be a competent professional.
- No part of any order, including previews, will be delivered until the balance is paid in full.
- Scott Huck Photography reserves the right to use negatives, digital scans, and/or reproductions for advertising, display, internet promotion, publication, or other purposes.

**Previews are sold to client and included in all packages, but all rights and copyrights to the photos remain with Scott Huck Photography.**

- Upon signature, Scott Huck Photography shall reserve the time and date agreed upon, and will not make other reservations for that time. For this reason, all deposits are non-refundable, even if the date of the wedding is changed or the wedding is cancelled for any reason.
- If Scott Huck Photography cannot perform this Contract due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to photographer's illness or emergency, then the Photographer shall return the deposit to the Client but shall have no further liability with respect to the Contract. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the Photographer. In the event that Scott Huck Photography fails to perform for any other reason, Scott Huck Photography shall not be liable for any amount in excess of the retail value of the Client's order.
- Client is aware that color dyes in photography may fade or discolor over time due to the inherent qualities of dyes, and Client releases Photographer from any liability for any claims whatsoever based upon fading or discoloration due to such inherent qualities.
- The charges in this Contract are based on Scott Huck Photography's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
- NOTICE OF COPYRIGHT: It is ILLEGAL to copy or reproduce these photographs elsewhere without Scott Huck Photography's permission and violators of this Federal Law will be subject to its civil and criminal penalties.
- This Contract incorporates the entire understanding of the parties. Any modifications of this Contract must be in writing and signed by both parties.
